

INTELLECTUAL PROPERTY AND CONTENT LIMITED LICENSE AGREEMENT AND TERMS AND CONDITIONS OF USE ("AGREEMENT")

Any purchase, receipt and/or use of photographs, animations, illustrations, images, videos, files, films, footage, media content, badges, logos, identifiers or other items ("Content") provided to You by Meals on Wheels America ("Association") through the Association Studio or otherwise, or the exercise of any rights to such Content, is subject to the Terms and Conditions contained herein. You hereby acknowledge, accept and agree that you, individually or on behalf of your employer or any other individual or entity for whom you are making such use (collectively, "You" or "Your"), have reviewed, understand and accept this Agreement for this non-exclusive, non-transferable, worldwide (unless territory is otherwise limited in an Addendum hereto) Limited License ("License") granted to You by Association subject to the Terms and Conditions contained in this Agreement. If You are accepting on behalf of Your employer or other individual/entity, You represent and warrant that You have full legal authority to bind Your employer or such other individual/entity. If You do not have such authority or You do not accept or agree with these Terms and Conditions, do not accept the Agreement and do not download or use the Content. You also agree that You have had the opportunity to seek the advice of an attorney before agreeing to be bound to these Terms and Conditions.

All Content provided by or through the Association Studio is owned by (or licensed to) the Association and is subject to and protected by copyright law and other commercial law. Other than the License provided for herein, all rights in and to the Content, including, without limitation, all copyright and other intellectual property rights relating to the Content, are retained by Association, and You are only granted a limited License to use such Content according to the Terms and Conditions contained herein.

This Limited License gives You the right to use the Content on or in any type of medium for any purposes not inconsistent with these Terms and Conditions, any additional terms and/or conditions included in any Addendum hereto, and with the mission of Association.

<u>TERM AND TERMINATION.</u> This term of the Limited License granted to You hereby shall be perpetual (unless a shorter term shall be provided for in a separate agreement or understanding between You and Association or as a result of the specific purposes for which such Content is accessed, and no longer) as long as You continue to comply with these Terms and Conditions. This Agreement shall be terminated when Content is no longer used and all Content is destroyed, or the period of use to which You are entitled ends. The Agreement shall also terminate and the Limited License shall end with or without notice if You fail to comply with any Term or Condition contained herein. Upon termination, You must cease using Content and destroy or delete all copies and uses of Content. You may be requested to confirm such action by Association. Any use not expressly permitted by this Agreement shall be prohibited and shall constitute infringement of copyright.

All copyright and other intellectual property rights pertaining to the Content are owned by Association, and the granting of this License does not imply a transfer of ownership. As Content is protected, You are therefore under the obligation to use the Content in a manner like any other protected product using the same safeguards as You normally use to protect such property of a similar character, but at least using reasonable care. Any partial or complete reproduction of any Content without the advance permission of

Association is prohibited. You recognize the value of the goodwill associated with this Limited License, in the rights licensed hereunder and, if applicable, in the use of any licensed trademark of Association. You also acknowledge that the use of any Content in the form of a Licensed Mark of Association and all the rights therein, and goodwill attached thereto, belong exclusively to Association and shall inure solely to the benefit of the Association.

<u>PERMITTED USES</u>: Unless otherwise provided, Content may be used an unlimited number of times for advertising, promotion, packaging, on-line use and related purposes in any medium (printed materials, brochures, posters, presentations, film, commercials, etc.). Content may be used for or on electronic publications, webpages and online videos. While Content (such as photographic images) may be resized proportionally from the size received from Association, other modifications to Content are prohibited (see below). Also permitted are other uses specifically approved in advance by the Association.

PROHIBITED USES: You may not:

- transfer, convey, give, rent, sell, re-sell, lend, assign, sub-license or otherwise transfer or distribute
 the Content (electronically or otherwise) or the rights granted under this Agreement, or use Content
 in a way intended for transfer, resale, sublicense, or the electronic or other distribution of Content
 alone or in conjunction with specific products or services (collectively "Commercial Use") in whole
 or in part without the advance written permission of Association and the completion and approval
 by Association of the Agreement Addendum for Limited License for Commercial Use of Content
 ("Commercial Use Addendum") available through the Association Studio. However, You may
 physically transfer Content from one location to another and may transfer or give Content to an
 employee or contracts for limited purposes of productions and reproduction. For example, You
 may not place a Content photographic image on a T-shirt or mug and sell such items without
 permission from Association (and completion of a Commercial Use Addendum). The Association
 retains and is entitled to all commercial rights to the Content (except for third party trademark and
 rights that are otherwise protected);
- use Content as any part of a trademark, trade or business name, service mark or logo;
- use or display Content in any way that would suggest an endorsement by the Association or any model or entity displayed in such Content and further, no image of any model or person in Content may be displayed in any manner that depicts such person in a potentially sensitive or suggestive manner that could reasonably be offensive or unflattering to such model or person or to the general public;

If You receive any notice for the Association or elsewhere or have other knowledge that any Content is subject to a threatened, potential or actual claim of infringement of another's right for which the Association may be liable, You must immediately and at Your own expense (i) stop using the Content; (ii) delete or remove the Content from Your premises, computer systems and storage (electronic or physical); and (iii) ensure that Your clients, printers or ISPs do the same. The Association will provide You with comparable Content at no cost to You under the same Terms and Conditions as provided for herein.

OTHER THAN AS EXPRESSLY PROVIDED HEREIN, THE CONTENT IS PROVIDED "AS IS" WITHOUT REPESENTATION, WARRANTY OR CONDITION OF ANY KIND, EITHER EXPRESS OR IMPLIED,

INCLUDING, BUT NOT LIMITED TO THE IMPLIED REPRESENTATIONS, WARRANTIES OR CONDITIONS OF MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. You agree to indemnify, defend and hold Association and its directors, officers, employees and agents (collectively, the "Association Indemnities") harmless from and against any and all claims, liability, losses, damages, costs and expenses (including reasonable legal fees) incurred as a result of or in connection with any breach or alleged breach by You or anyone acting on Your behalf of any of the terms of this Agreement.

If applicable, You agree to pay and be responsible for any and all sales taxes, use taxes, value added taxes and duties imposed by any jurisdiction as a result of the license granted to You, or of Your use of the Content, pursuant to this Agreement. Association's failure to enforce strict performance of any provision of this Agreement shall not be construed as a waiver of any provision or right. This Agreement is not assignable by You without Association's prior written consent. If all or part of this Agreement is unenforceable, the parties or, in the event the parties are unable to agree, a court of competent jurisdiction, shall put in place of such whole or part provision an enforceable provision or provisions, that as nearly as possible reflects the terms of the unenforceable whole or part provision.

This Agreement may be amended at any time by Association with or without notice to You. You shall be responsible for the review of the Terms and Conditions prior to the Use of Content and You agree and consent to the Terms and Conditions in place at the time of the use of Content.
