# UTAH'S AGING POPULATION: BY THE NUMBERS



**NOTE:** This fact sheet presents the most recent data for older adults living in Utah and senior nutrition programs receiving federal funding through the Older Americans Act (OAA) in Utah. Except where noted otherwise, "seniors" refers to adults age 60 or over, the primary age group served by the OAA.

# POPULATION SIZE AND DEMOGRAPHICS

## AGE 60 AND OVER POPULATION

- Total population of adults age 60+: 560,166 (16.6%)

  - Seniors experiencing reduced quality, variety, or desirability of diet (low food secure)\*\*: 43,167 (7.6%)
    - Seniors experiencing reduced food intake (very low food secure): 15,055 (2.6%)
- Senior households receiving Supplemental Nutrition Assistance Program (SNAP): 18,446 (5.3%)
- Seniors eating less than 1 vegetable a day: 17.3%
- Seniors eating less than 1 fruit a day: **29.6%**

# SOCIAL ISOLATION

- Seniors living alone: 102,281 (19.1%)
- State ranking for risk of social isolation age 65+: 1st in U.S.

# POVERTY

- Seniors living below the poverty line:
  - Supplemental poverty measure: 47,447 (8.9%)
  - Official poverty measure: **35,069 (6.7%)**
- Seniors age 65+ who lack income to pay for basic living needs
  - Singles: 40.4%
  - Couples: 16.0%

# HEALTH CARE UTILIZATION AND COSTS

## **HEALTH AND DISABILITY**

- Seniors with a disability: 26.9%
- Seniors reporting "fair" to "poor" health: 19.5%
- Medicare participants age 65+ with multiple (3+) chronic conditions: **58.0%**

# FALLS AND HEALTH CARE UTILIZATION

- Seniors experiencing fall with injury/year: 10.7%
- Hospital readmissions within 30 days among Medicare participants age 65+: 14.0%
- Preventable hospitalizations among Medicare participants age 65+: 1.5%

# MEALS ON WHEELS AMERICA FEDERAL ADVOCACY PRIORITIES

- 1. Increase funding and support for senior nutrition programs. Reauthorize and provide sufficient funding for the Older Americans Act (OAA), protect other federal funding sources for Meals on Wheels programs, and improve charitable giving and volunteer tax incentives to generate more resources and capacity for community-based organizations.
- 2. Strengthen and secure nutrition access for older adults. Maintain important federal funding flexibility and delivery, modernize OAA policies to support senior nutrition programs and innovation, and address senior hunger and malnutrition in the reauthorization of the Farm Bill.
- 3. Advance Food as Medicine interventions. Include home-delivered meal benefits in Medicare, Medicare Advantage and Medicaid and medically tailored meal initiatives with community-based senior nutrition programs.
