# HAWAII FACT SHEET

# POPULATION, DEMOGRAPHICS AND NEEDS

### **SENIOR POPULATION**

- Total population of adults age 60+: 357,627 (25.3%)
- Race
  - Black/African American: 0.8%

- Seniors facing hunger (very low food secure): 4,755 (1.4%); Rank: 47<sup>th</sup> in U.S.
- Seniors eating 3+ vegetables a day: 16.2%
- Seniors eating 2+ fruits a day: 36.5%

## **SOCIAL ISOLATION**

- Seniors living alone: 65,571 (18.8%)

- Seniors living below the poverty line: 30,169 (8.6%)

#### **HEALTH AND DISABILITY**

- Seniors living with a disability: **28.8%**
- Seniors reporting "fair" to "poor" health: 22.7%
- Medicare beneficiaries with multiple (4+) chronic conditions: **36.3%**

#### FALLS AND HEALTHCARE UTILIZATION

- Seniors experiencing fall with injury: 8.1%
- Hospital readmissions within 30 days among Medicare participants (2020): 14%
- Preventable hospitalizations among Medicare participants (2020): **14.3 per 1,000**
- Nursing facility residents with low-care needs: 2.7%; Rank: 48<sup>th</sup> in U.S.

#### **HEALTHCARE COSTS**

- Total Medicare spending: **\$1,067,765,931**
- Medicaid spending for nursing facilities (2020): \$53,915
- Medicare beneficiaries who are dually eligible for Medicaid: **41,302 (15%)**
- Cost of 1 day in a hospital: **\$2,680**

# MEALS ON WHEELS AMERICA KEY FEDERAL PRIORITIES

- 1. Increase federal funding for the Older Americans Act Nutrition Program, and other funding sources including federal block grants and home- and community-based services (HCBS).
- 2. Advance policies that support community-based nutrition programs serving more older adults including a strong and coordinated implementation of the 2020 reauthorization of the Older Americans Act, convening a White House Conference on Food Nutrition, Hunger, and Health, and incentivizing leverage of the senior nutrition network in healthcare.
- **3.** Strengthen other federal anti-hunger programs that benefit older adults and their families, including the Commodity Supplemental Food Program (CSFP) and the Supplemental Nutrition Assistance Program (SNAP).
- **4.** Enhance charitable giving incentives and assistance for nonprofit organizations under the tax code.
