

**NOTE:** This fact sheet presents the most recent data for older adults living in Texas and senior nutrition programs receiving federal funding through the Older Americans Act. These data are from 2018-2019 unless noted and therefore do not reflect any changes due to the pandemic.

## POPULATION, DEMOGRAPHICS AND NEEDS

### SENIOR POPULATION

- Total population of adults age 60+: **5,287,626 (18.2%)**
- Race
  - Black/African American: **10.4%**
  - White:
    - Hispanic: **23.6%**
    - Non-Hispanic: **60.0%**
  - Asian: **4.2%**
  - American Indian and Alaska Native: **0.8%**

### FOOD INSECURITY AND NUTRITION

- Seniors threatened by or experiencing hunger (marginally food insecure)\*\*: **927,310 (17.8%)**; Rank: **5<sup>th</sup>** in U.S.
- Seniors at risk of hunger (food insecure)\*\*: **541,147 (10.4%)**; Rank: **5<sup>th</sup>** in U.S.
- Seniors facing hunger (very low food secure): **187,722 (3.6%)**; Rank: **11<sup>th</sup>** in U.S.
- Seniors eating 3+ vegetables a day: **16.4%**
- Seniors eating 2+ fruits a day: **38.5%**

### SOCIAL ISOLATION

- Seniors living alone: **1,110,760 (21.3%)**
- State ranking for risk of social isolation: **31<sup>st</sup>** in U.S.

### POVERTY

- Seniors living below the poverty line: **544,797 (10.4%)**

### HEALTH AND DISABILITY

- Seniors living with a disability: **30.9%**
- Seniors reporting “fair” to “poor” health: **28.6%**
- Medicare beneficiaries with multiple (4+) chronic conditions: **43.2%**

### FALLS AND HEALTHCARE UTILIZATION

- Seniors experiencing fall with injury: **13.2%**
- Hospital readmissions within 30 days among Medicare participants (2020): **16%**
- Preventable hospitalizations among Medicare participants (2020): **30.6 per 1,000**
- Nursing facility residents with low-care needs: **7.5%**; Rank: **34<sup>th</sup>** in U.S.

### HEALTHCARE COSTS

- Total Medicare spending: **\$28,582,542,702**
- Medicaid spending for nursing facilities (2020): **\$364,716,917**
- Medicare beneficiaries who are dually eligible for Medicaid: **712,182 (17%)**
- Cost of 1 day in a hospital: **\$2,633**

## MEALS ON WHEELS AMERICA KEY FEDERAL PRIORITIES

1. Increase federal funding for the Older Americans Act Nutrition Program, and other funding sources including federal block grants and home- and community-based services (HCBS).
2. Advance policies that support community-based nutrition programs serving more older adults including a strong and coordinated implementation of the 2020 reauthorization of the Older Americans Act, convening a White House Conference on Food Nutrition, Hunger, and Health, and incentivizing leverage of the senior nutrition network in healthcare.
3. Strengthen other federal anti-hunger programs that benefit older adults and their families, including the Commodity Supplemental Food Program (CSFP) and the Supplemental Nutrition Assistance Program (SNAP).
4. Enhance charitable giving incentives and assistance for nonprofit organizations under the tax code.
